ZMAP-2019-0019	Rezone the property from TR-ILF and TR-3LF to R-8 residential zoning.
SPEX-2020-0019	Special Exception to reduce front yard for quadruplex units to 8'.
ZMOD-2020-0005	Zoning modification to allow single-family detached and attached frontage and access to private streets.
ZMOD-2020-0006	Zoning Modification to permit site access from and proposed median break not previously planned by Loudoun County or VDOT.
ZMOD-2020-0007	Zoning Modification to waive off-site parking requirement for single-family attached units.
ZMOD-2020-0017	Zoning Modification to allow single-family detached and duplex units to front on private roads.
ZMOD-2020-0018	Zoning Modification to eliminate trees along certain types of private streets.
ZMOD-2020-0019	Zoning Modification to reduce the minimum lot width for quadruplex units from 24' to 20'.


