Dominion Energy Transmission, Inc. (DETI), an interstate gas pipeline company, is taking this opportunity to notify you, in accordance with the Federal Energy Regulatory Commission (FERC) Guidelines, of our upcoming routine Linear Anode install on natural gas pipeline TL-522 on, or adjacent to, your property in Loudoun County, VA and within our easement. DETI, headquartered in Bridgeport, West Virginia, has been operating a regional network of natural gas pipelines and storage facilities throughout West Virginia, Ohio, Maryland, Virginia, Pennsylvania, and New York since 1898.

A brief description of the work and the effect the activity may have on, or near, your property is provided below:

- Our field crews will make the necessary arrangements to prepare for several weeks of work at the job site. Various types of equipment will be on site to assist with the project. The project will take place entirely within the pipeline TL-522 right-of-way corridor and designated access roads.
- The planned routine maintenance is to trench/excavate parallel to the pipe in various sections for 27 miles, approximately 5'-10' horizontally from the pipe and install anticorrosion linear anodes at the depth of the pipe at designated sections within the pipeline right-of-way. Earth disturbance and excavated areas will be finish graded, seeded and mulched to prevent erosion. Please keep in mind that upon the completion of construction DETI will reclaim all surface damages to as good as or better than original conditions.

• The work on or near your property should take DETI approximately 1 week to complete. The entire 27 miles of the project is expected to be completed within 4 months and will commence around the spring of 2021.
