



KIRKPATRICK FARMS COMMUNITY ASSOCIATION SWIMMING POOL GUIDELINES

Conferral of Authority: The pool management staff (the pool manager, assistant manager, lifeguards, and gate attendant), Cardinal Management Group, and the Kirkpatrick Farms Community Association, Inc. (KPFCA) Boards of Directors have absolute authority for the operational and safety conditions of the pool and the enforcement of the below-listed pool regulations.

Mission Statement: The Kirkpatrick Farms Community Association, Inc. is committed to ensure that all residents and guests have a safe and enjoyable recreation experience when using the KPFCA pool. Any incident or practice that mars such an experience, even if not specified below, should be referred to the Kirkpatrick Farms Community Association's Board of Directors.

NON-COMPLIANCE MAY RESULT IN IMMEDIATE EXPULSION AND A MINIMUM 48-HOUR SUSPENSION FROM THE POOL.

DECISIONS OF THE LIFEGUARDS ARE FINAL

1. A KPF Key FOB is required for entry; Members must be registered and in good standing via Cellbadge to access the pool.
2. Adults, 18 years or older may bring up to 5 guests per visit; Minors, under 18 may bring 1 guest per visit. Each household will receive twenty (20) free guest passes for the season.
3. Minors, 12 years old and under, must be accompanied by a person 16 years of age or older.
4. An adult, capable of swimming and in appropriate swim attire, must always be within arm's reach of a non-swimmer, and able to assist in the event of an emergency.
5. Appropriate swim attire is required at all times.
6. Non-toilet-trained children and incontinent individuals must wear a swim diaper while in the pool.
7. All swimmers must shower before entering.
8. Only Coast Guard-approved flotation devices are allowed. Other flotation devices are prohibited unless required for a disability—notify pool staff upon arrival.
9. Only Kirkpatrick-approved balls will be permitted in the pool. Balls will be made available at pool check-in. All other balls are prohibited from the pool, pool deck, and locker rooms.

10. Only Kirkpatrick-approved water guns and water-squirting devices will be permitted in the pool. Water guns and squirters will be made available at the time of check-in. All others are prohibited from the pool, pool deck, and locker rooms.
11. The Wading Pool is restricted to children under 6 years old with an adult who must remain within arm's reach. (see Rule 5)
12. No playing around drains, No running, No roughhousing, No tag, No fighting, No horseplay, No throwing patrons in the pool, No sitting/standing on shoulders, or unsafe behavior in the pool, pool deck, or locker rooms.
13. No breath-holding games or diving.
14. No abusive/profane language or disruptive behavior.
15. The pool will be cleared for 10 minutes every hour for safety checks; three whistle blasts mean exit the pool immediately. Lap lanes will remain open for lap swimming only.
16. No smoking (including E-cigarettes), No alcoholic beverages of any kind, and persons under the influence of alcohol will NOT be allowed within the pool area.
17. No glass containers of any kind will be allowed in the pool area.
18. Food and drinks must be kept at least 5 feet from the pool's edge.
19. Electronics must be kept away from water. Volume must remain at a responsible level so as not to disturb others.
20. Do not distract lifeguards. They have full authority over pool safety and operations.
21. If no lifeguard is present, the pool is closed—no entry allowed.
A chairlift is available for those needing assistance.
